## Commercial Application Form

### Program Instructions, Limitations and Terms

#### Devices must be installed prior to submitting application

1. The rebate amounts listed are applicable only to **WaterSense® labeled high-efficiency tank type toilets** and **flushometer valve toilets**. Tank type toilets being replaced must have been installed prior to December 31, 1996 to qualify for the \$125 rebate. Tank type toilets installed after December 31, 1996 qualify for the \$25 rebate. Flushometer valve toilets must have been installed prior to December 31, 1996 to qualify for the \$200 rebate. Flushometer valve toilets installed after December 31, 1996 qualify for a \$75 rebate.
2. Rebate amounts are not to exceed purchase price of qualifying products.
3. New construction is eligible for a \$25 rebate per installed tank type toilet and \$75 rebate per flushometer valve toilet installed.
4. **A maximum rebate of \$1000 applies per installation address. Please contact Water Conservation Division staff for pre-approval for any project resulting in a rebate request greater than \$1000.**
5. All restaurant, hotel, or multi-family retrofit projects must be pre-approved by City of Bozeman Water Conservation Division staff.
6. Only toilets connected to the City of Bozeman public water supply are eligible for rebates.
7. Old toilets can not be reused. Applicants agree to destroy or disable their old toilets.
8. Installation of toilets is the sole responsibility of Applicant.
9. The toilets must be installed at the installation address listed.
10. A copy of the sales receipt is to be attached to this application. Receipts must include the make and model of the toilet(s) purchased. The purchased toilet model number(s) must match exactly the **WaterSense®** list to qualify for a rebate. Mixing and matching of tanks and bowls from this list is not permitted.
11. The effective date of the Commercial Tank Type Toilet Rebate Program January 1, 2019. Rebates for tank type toilets purchased prior to January 1, 2019 will not be given. The effective date of the Flushometer Valve Toilet Rebate Program is January 1, 2019. Rebates for flushometer valve toilets purchased prior to January 1, 2019 will not be given.
12. To ensure water savings are achieved, the tank type toilets and flushometer valve toilets installations must be maintained for a period of five (5) years minimum. If any tank type toilets and flushometer valve toilets need to be replaced in this time, the participant agrees to replace with products of equal or greater efficiency.
13. Applications will be processed in the order they are received. Incomplete applications can be denied and returned to Applicant or result in a delay of the approval of the rebate.
14. Limited funding is available to issue rebates. Rebates will be issued on a first-come, first served basis through June 30, 2024. The City cannot guarantee that submittal of a rebate application will result in issuance of a rebate check. The Commercial Toilet Rebate Program is subject to change or cancellation without notice.
15. A rebate check will be mailed within forty-five (45) days of receipt provided the application is complete and funding is available.
16. A 1099 Tax Form is required of any parties that have been issued a total rebate amount equal to, or in excess, of \$600 by the City of Bozeman within one tax year.

#### Important! Please read carefully:

1. Proof of installation must accompany this application. Proof may take the form of an invoice from a certified plumber or a photo of the new toilet(s) after installation. Applications without proof of installation will not be considered for a rebate.
2. The City reserves the right to do an on-site inspection to verify installation of the toilets rebated through this program. Access to the rebated toilets must be provided at the time of inspection. If toilet installations cannot be verified, the payee will reimburse the City for the rebate funds received.
3. The City may contact Applicant by phone or in writing to verify information provided for in the application and/or to schedule an inspection. Any inspection shall occur during regular business hours.

#### Disclaimer

The City makes no representation or warranty regarding the toilets eligible for rebate under the Commercial Toilet Rebate Program. By participating in the program you waive and release the City from any and all claims and causes of action arising out of the purchase, installation, or use of the toilets purchased in connection with the rebate program. Any claim you may have based upon any defect or failure of performance of a toilet purchased should be pursued with the manufacturer/distributor. City verification inspections are not a certification, warranty, or other approval with respect to the Applicant's compliance with applicable laws, ordinances and building codes.
