Program Instructions, Limitations and Terms

Unit must be installed and operational before submitting your application

1. The rebate amount listed is applicable only to **new, WaterSense® labeled high-efficiency showerheads**.
2. A rebate of \$20 will be issued for qualifying showerheads.
3. A maximum rebate of \$40 for two new qualifying showerheads applies per application. Rebate amounts are not to exceed purchase price of qualifying products. Pre-approval is required for Applicant seeking a rebate of greater than \$40.
4. New construction is eligible for a \$10 rebate per installed WaterSense® showerhead(s).
5. New, qualifying showerheads may be purchased online if they cannot be purchased from a local retailer.
6. Tenants must submit an owner authorized letter.
7. Only showerheads connected to the City of Bozeman public water supply are eligible for rebates.
8. Old showerheads cannot be reused. Applicants agree to destroy or disable their old showerhead(s).
9. Installation of showerheads is the sole responsibility of Applicant and showerhead(s) must be installed at the installation address listed.
10. A copy of the sales receipt is to be attached to this application. Receipts must include the make and model of the showerhead(s) purchased. The purchased showerhead(s) model number(s) must match exactly the WaterSense® list to qualify for a rebate.
11. The effective date of the Bozeman Showerhead Rebate Program is January 1, 2016. Rebates for showerhead(s) purchased prior to January 1, 2016 will not be given. Rebate amounts and eligible showerheads are subject to change at any time.
12. Applications will be processed in the order they are received. Incomplete applications could be denied and returned to Applicant or result in a delay of the approval of the rebate.
13. To ensure water savings are achieved, the showerheads installations must be maintained for a period of five (5) years minimum. If any showerheads need to be replaced in this time, the participant agrees to replace with products of equal or greater efficiency.
14. Rebates will be issued on a first-come, first served basis through June 30, 2024. The City cannot guarantee that submittal of a rebate application will result in issuance of a rebate check. The Bozeman Showerhead Rebate Program is subject to change or cancellation without notice.
15. A rebate check will be mailed within forty-five (45) days of receipt provided the application is complete and funding is available.
16. Multi-family customers interested in bulk retrofit projects that exceed maximum rebate amounts must seek pre-approval prior to installation of any fixtures. Please contact the Water Conservation Division for more information or review the City's Commercial Rebate Program requirements.
17. A W-9 Tax Form is required of any parties that have been issued a total rebate amount equal to, or in excess, of \$600 by the City of Bozeman within one tax year. Applicant must submit a completed W-9 form in order for City to approve rebate applications for \$600 or more.

Important! Please read carefully:

1. Proof of installation must accompany this application. Proof may take the form of an invoice from a certified plumber, or a photo of the new showerhead(s) after installation. Applications without proof of installation will not be considered for a rebate.
2. The City reserves the right to do an on-site inspection to verify installation of the showerhead(s) rebated through this program. Access to the rebated showerhead must be provided at the time of inspection. If showerhead(s) installation cannot be verified, the payee will reimburse the City for the rebate funds received.
3. The City may contact Applicant by phone or in writing to verify information provided for in the application and/or to schedule an inspection. Any inspection shall occur during regular business hours.

Disclaimer

The City makes no representation or warranty regarding the showerhead(s) eligible for rebate under the Bozeman Showerhead Rebate Program. By participating in the program you waive and release the City from any and all claims and causes of action arising out of the purchase, installation, or use of the showerhead(s) purchased in connection with the rebate program. Any claim you may have based upon any defect or failure of performance of a showerhead purchased should be pursued with the manufacturer/distributor. City verification inspections are not a certification, warranty, or other approval with respect to the Applicant's compliance with applicable laws, ordinances and building codes.
