



C. CASH RESERVE: The Administrative Rules of Montana allow the building division to maintain a "cash reserve fund" derived from building permit fees provided that the reserve amount does not exceed the building division operating costs for a 12 month period. Our estimate of the building division budget for FY16 is \$1,978,444. At the beginning of the 1st quarter the Building Inspection Fund Cash Reserve was \$1,676,315. At the end of the 1st quarter our Cash Reserve balance was \$1,708,654.

G. STAFFING: Our current staff consists of the Chief Building Official, two Building Permit Coordinators, one Building Permit Technician, two Plans Examiners, seven Building Inspectors and two Fire Inspectors. At this time, we have one vacant Code Compliance Technician position, one vacant Building Inspector II position and one vacant Plans Examiner position. We are currently recruiting for a Building Inspector II.

H. SUMMARY: Revenue, Expenditures, Reserve Fund;

Our monthly revenue for the 1st Quarter averaged \$147,159 per month and totaled \$441,447 for the quarter.

Our monthly expenditures for the 1st quarter averaged \$136,379 per month and totaled \$409,137 for the quarter.

The Building Division Reserve Fund balance at the end of the 1st Quarter was \$1,556,293.
