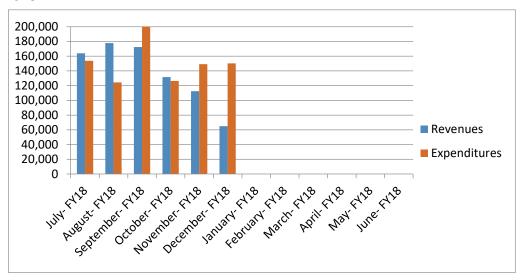

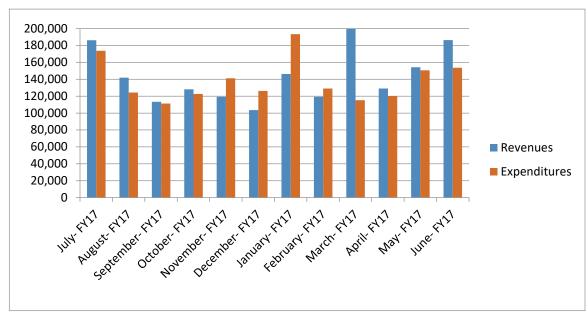
CASH RESERVE: The Administrative Rules of Montana allow the building division to maintain a "cash reserve fund" derived from building permit fees provided that the reserve amount does not exceed the building division operating costs for a 12 month period. Our estimate of the building division budget for FY18 is \$2,086,952. At the beginning of the 2nd quarter the Building Inspection Fund Cash Reserve was \$1,662,728. At the end of the 2nd quarter our Cash Reserve balance was \$1,545,485 which equates to a 7% decrease for the quarter.

STAFFING: Our current staff consists of the Chief Building Official, two Building Permit Coordinators, one Building Permit Technician, one temp Building Permit Technician Trainee, two Plans Examiners, six Building Inspectors, one Building Inspector/Code Compliance Officer, two Fire Inspectors and one temp part time Filing Clerk.

In addition, we are using a 3^{rd} party plan review firm to assist us with our building plan review. Approximately 28% of our building plan review during the first two quarters of 2018 were completed by our 3^{rd} party plan review firm.

At this time, we have two vacant Building Inspector II positions and one vacant Plans Examiner position.
