


CASH RESERVE: The Administrative Rules of Montana allow the building division to maintain a "cash reserve fund" derived from building permit fees provided that the reserve amount does not exceed the building division operating costs for a 12 month period. Our estimate of the building division budget for FY18 is \$2,086,952. At the beginning of FY18, the Building Inspection Fund Cash Reserve was \$1,767,487. At the end of the 3<sup>rd</sup> quarter our Cash Reserve balance was \$1,595,763. The \$171,724 reserve reduction equates to a 9.7% decrease.

**STAFFING:** Our current staff consists of the Chief Building Official, two Building Permit Coordinators, one temp Building Permit Technician Trainee, two Plans Examiners, five Building Inspectors, one Building Inspector/Code Compliance Officer, two Fire Inspectors and one temp part time Filing Clerk.

In addition, we are using a 3<sup>rd</sup> party plan review firm to assist us with our building plan review. Approximately 35% of our building plan review during the third quarter of 2018 was completed by our 3<sup>rd</sup> party plan review firm.

At this time, we have three vacant Building Inspector II positions and one vacant Plans Examiner position.
