


FORESTRY DIVISION PERMIT - PLANTING

INTRODUCTION	
This permit is for persons requesting to plant trees in public areas. Pursuant to City of Bozeman Municipal Code (Ch.16 - Article 5. Trees and Other Vegetation), all tree planting in public areas shall adhere to the following conditions and standards:	
	Trees shall have a minimum caliper size of 1.5 inch and be free of defects.
	Tree quality and structure shall conform to the latest standards of the American Standard for Nursery Stock (ANSI Z60.1)
	Utility locates shall be requested and clearly marked at time of planting. (1-800-424-5555)
	Tree species selection shall conform to the Forestry Division Street Tree Guide.
	Each planting shall conform to spacing standards as per detail. (See Reverse)
	Trees shall be planted at the appropriate level, with trunk/root flares clearly visible at finished grade.
	Each planting shall include an application of organic mulch as per detail.
	Trees shall be properly staked for (1) year as per detail.
	Drip or Bubbler irrigation shall be in place for the root zone of each tree. If not, alternative watering methods shall occur during dry conditions for (2) years following planting.

Planting Detail LOCATE ANCHOR STAKES (2) 18° AWAY FROM TREE TRUNK. WOOD OR IRON STAKE, ANCHOR FIRMLY. REMOVE ATTAINER FORTECTOR. NON-ABRASIVE ATTAINER FORTECTOR. NON-ABRASIVE ATTAINER ANTOH SOIL SAUGER. 3-4" IN DEPTH, KEEP CLEAR 2-3" FROM TRUNK FLARE. FIRMLY FORMED SOIL SAUGER (USE TOPSOIL). REMOVE TOP 13 OF BURLAP. REMOVE TOP 13 OF BURLAP. REMOVE TOP 13 OF WIRE BASKET & ALL TWINE. PROPER DEPTH EXPOSING TRUNK FLARE. ROUGHEN SIDES OF PIT. UNDISTURBED SOIL - DIG PIT TO PROPER DEPTH PLANTING SOIL (BACKFILL)

Spacing Restrictions



<u>Street Vision Triangle</u> – No planting within 40' triangle on Collector and Local Streets; 50' triangle on Arterial Streets. No planting within 30' centerline of driveways (15' either side).

<u>Boulevard Tree Spacing</u> – Plantings shall be spaced a minimum of 25' on center for smaller species; 30' on center for larger species.

Utility Spacing - No tree shall be planted within 10' of any utility.
